Biography

Giulio Palermo is an arbitration specialist qualified in Switzerland, Italy and Spain.

He has participated in over 90 international arbitration proceedings, serving as arbitrator in more than 50 of them ([see full list of cases](#)). The proceedings were conducted in English, Spanish, French, and Italian and administered by all major arbitral institutions (e.g. International Court of Arbitration, Court of Arbitration for Sport, Swiss Chambers' Arbitration Institution, Corte de Arbitraje de Madrid, London Court of International Arbitration, Milan Chamber of Arbitration, etc.), in matters including transnational sales contracts, construction, shareholders' agreements, agency, distribution and license agreements, joint ventures, post M&A disputes, sport etc.

In 2023, he has been ranked among the 40 best lawyers (worldwide) in the category Global Elite Thought Leader – Under 45 by Who's Who Legal. In 2020, he was voted as the most highly regarded arbitration practitioner in Europe by Who's Who Future Leaders.
